# **PROPERTIES**

**DECACOLOR** is a stripper combining **several acids** (phosphoric, citric et chlohydric) and surface active agents.

DECACOLOR's revolutionary formula (world patent) entails a change in the colour of the product depending on the dilution, which allows a visual control to adjust concentration to the cleaning task

**DECACOLOR** allows **immediate cleaning of laitance, efflorescence and cement residues** on all surfaces as well as zinc pickling prior to welding **without smoke emissions**.

**DECACOLOR** is the best product to **descale** and **eliminate lime deposits**.

Being multi-puprpose, DECACOLOR also allows to clean all dirty surfaces (facades, terraces, pool decking,...) whatever the material (stone, floor tiling, rendering, concrete, etc...);

**DECACOLOR's high emulsifying power allows to clean oils and greases.** 

**DECACOLOR** contains a **powerful corrosion inhibitor** (ideal for reinforced concrete, does not attack reinforcements)

### INSTRUCTIONS FOR USE

**DECACOLOR** can be used **pure or diluted** according to the needs. **The colour of the product indicates the level of concentration**.

**RED**: Pure: Only to be used for **very difficult stripping**.

**ORANGE**: High concentration: use for **thorough cleaning** and **pickling**.

**YELLOW**: Eliminates cement residues in concrete mixers, work site materials, lorry sideboards, etc... **Cleans after tile laving**.

**GREEN**: Renovation of **dirty floors** (workshops, garages, service stations) and **pickling of floors** before painting.

**BLUE**: For a **smooth cleaning** on all surfaces. Efficient enough to eliminate **cement or lime veil** on floor tiling, for example.

### Important:

It is a **reversible system**: If dilution is too high, just add more product until you get **the appropriate colour**.

### Rinsing:

The product is **neutralized by water**. Neutralization is complete **when the blue colour has vanished**.
